<u>Justification and Sin</u>

If you're a Christian in the 21st century, you've been affected by Martin Luther's doctrine of justification by grace through faith. It doesn't matter if you're Roman Catholic, or Eastern orthodox, or if you've never heard of Luther at all. So, I'd like to write about justification for a moment, and its corollary, sin.

Justification by grace through faith is the claim that a person does not need to earn their good standing before God, but rather, God grants this good standing, freely, simply out of divine, fatherly goodness and mercy. People are invited to believe that they are of infinite value simply because they are human beings.

From this perspective, sin, as a doctrine, functions as a safeguard against any assault on justification. If a person asserts their own merits as the basis of their worth, the retort is, But you are a sinner. Whatever your merits, they do not cancel out the reality of your sin. Take the example of an otherwise good man, convicted of murder. It does that good man no good to say, But there are plenty of people I haven't murdered. He stands convicted, and the only way out for him is a pardon.

Over the years, and more so in certain wings of Christendom than others, the doctrine of sin has been magnified to the extent that it is taught that there is nothing good that dwells in people, and that people are essentially bad and worthless.

Further, the doctrine of sin has taken priority over the doctrine of justification. That is, it has been thought that the doctrine of justification stands or falls with the doctrine of sin. If it could be shown that the doctrine of sin were incorrect, then justification would collapse.

What has been forgotten is that the doctrine of sin is born out of the doctrine of justification, and not the other way around. The doctrine of sin is intended to safeguard the doctrine of justification, not to stand on its own merits (pun definitely intended). When someone has been told that their worth is not based on their own merit, but then retroactively reads their good works back into the declaration, the doctrine of sin stands as a reminder that that way is barred. No one earns their standing. Try it, and you will only see how far short you fall.

Further, it is only in the light of justification that sin makes any sense. One who has been declared perfectly good may indeed fail to live up to that high calling, and thus be seen to be a sinner. On the other hand, no one expects anything out of someone in whom

nothing good whatsoever lives. Such a person hasn't fallen at all. They started at the bottom.

To go one step further, let us suppose that there were a perfect man who had never once stumbled or sinned. Justification asserts that even that man's standing before God is not based on their merits. Their value is not a question of their works. They are valuable simply because they are human beings.


When it comes to human worth, the very concept of merit is a category mistake. It's not that human beings can't amass enough "goody goody points" to please God. It's that "goody goody points" are completely unnecessary, and even an affront to the gracious declaration: you are valuable simply because you are.

Sin is not the article on which the doctrine of justification stands or falls. Rather, to use the old Lutheran language, justification is the article on which the church (including its doctrine of sin) stands or falls. Justification is primary. The doctrine of sin is merely supportive, and should never be considered foundational.

Income and Expenses Summary Notes:

The YTD period ending April 30, 2019, has an operating surplus of \$12,486, year-to-date at April 30, 2018 was a deficit. Congregational Contributions through April 2019 are \$5K less than contributions received through April 2018, a decrease of 3.5%.

Building Use/Other Income is \$1400 more than the amount at this time last year. Total Income at April 30, 2019, is \$3500 less than at April 30, 2018. Congregational Contributions are under budget by nearly \$28K and Total Income is under budget by nearly the same amount.

Note: Other Income includes periodic gifts made by the Thrivent Choice Donation program, clothing recycling program, and other miscellaneous unrestricted income.

Expenses

Total expenses were under budget by just over \$12K as of April 30, 2019. Total expenses YTD are \$1200 less than total expenses as of April 2018. Note: Benevolence payments are percentages of contributions. Therefore, when contributions are higher, benevolence payments are higher.

PROPERTY COMMITTEE

The Property Committee continues to concentrate on researching the details of proposed repairs and improvements, and then determining the scope, cost, and timing of the work required.

The committee has received a proposal from Cathedral Crafts Inc. of Winona, MN., for completely replacing the exterior plastic windows and aluminum trim with new double strength glass panes and extruded trim. The proposal also includes painting/repairing/replacing the rotted areas of wood framing around some of the stained glass windows. The cost for this proposal exceeds the amount typically funded within the 15 year plan, so the committee will continue to solicit more proposals.

The rearrangement of the office is entering the last phases of the project. Installation of carpet and a new book shelf unit in the new pastor's' office will be completed soon, making it both attractive and functional.

The Preschool room reported a loss of power to all wall outlets and the ceiling fans in the rooms. Investigation showed that all wall outlets from the Sunday School office to the west end of the hall were out. Ultimately a wire in conduit below the concrete floor in the east preschool room was found to have shorted out in the underground metal conduit due to age and the deterioration of the conduit. This is a situation that we are likely to experience again as the building ages. A certified, licensed electrician has been working with Property to find the problem, and will be preparing a report for the Property Committee detailing what we can do to help make the next event easier to track and repair. Property Committee will forward the report and recommendations to the Church Council as soon as it is received and reviewed.

Thanks to the Congregation for your continued faith in the Property Committee and the 15 Year Plan. Please prayerfully consider your giving status so that the Church Council and Property Committee can confidently proceed with the replacement of the Sanctuary roof before a failure occurs and renovation work in the sanctuary below is put in jeopardy.

SHEEP AND GOATS FOCUS

MISSIONARIES BRUCE AND SONYA WALKER

Bruce and Sonya Walker have been providing educational and humanitarian services for almost 17 years in a country in Southeast Asia. They provide daily sharing of the Word along with financial and medical support.

After one and a half years of resistance, Bruce was able to get a program in the school system to wash hands and brush teeth as these hygiene practices are not normally done in homes in a third world country. The program has proven to be beneficial in reducing the transmittal of viruses. The government has since recognized the benefits and has taken over the program.

Three major disasters have taken place causing total devastation of three islands (Lombok, Palu, and Benten) and the loss of many lives. They traveled to and established clinical shelters to provide medical and spiritual support. Some of the members of the team have returned to follow up.

Their recent emphasis has been in teaching and training young health care professionals to travel to outlying islands to spread the message to their own people. Because of their efforts, there are many who now believe in Christ. They believe that this is an exciting time in their ministry and they are grateful for the support that St. Paul has provided.

Bruce will be doing a presentation at the 8:30 and 11:00 services on June 23rd. He and Sonya will be available to answer questions between services.
