#### Income and Expenses Summary Notes:

#### Overall Comments and Income Review

2020 has an operating surplus of just over \$31,000, about \$3,600 better than at December 31, 2019. However, Congregational Contributions through December 2020 are more than \$36,000 less than contributions received through December 2019, a reduction of 9.1%. Total Income at December 31, 2020, is \$41,456 less than at December 31, 2019. Congregational Contributions finished 2020 under budget by \$37,570 and Total Income is under budget by \$44,074. In December, we received a \$2,126 rebate from the Ohio Bureau of Workers' Compensation as part of Ohio's response to the economic effect of the pandemic.

Note: Other Income includes periodic gifts made by the Thrivent Choice Donation program, clothing and paper recycling programs, and other miscellaneous unrestricted income.

#### Expenses Review

Total expenses are under budget by about \$75,363 as of December 31, 2020. Total expenses YTD are just over \$45,000 less than total expenses as of December 2019. We finished the year 11.6% under budget.





Pastor Dan Skillman: By default the Pastor is always a member of council.





As you have probably seen, at least three new strains of the Covid19 virus have emerged, and initial information indicates that the new strains are up to 70% easier to transmit, and at least one new strain attacks the human body with greater strength. Social distance, hand washing, and masks are still the major keys to protecting yourself, and those you love, from being infected. Now with new and more dangerous viruses on the rise, the church council has assumed the responsibility for determining what heating and ventilation systems will be operated and when.

As mentioned during the congregational meeting, what we may be able to do this coming year depends upon the availability of the materials and parts required for a job more than anything. The virus has many materials and manufacturing companies operating at only partial output because of so many ill workers. We have entered a contract with E&L Heating and A/C to replace the 46 year old office air conditioning equipment, and the contractor has located and purchased the equipment needed so that about mid April we will be able to do this job. We are in the process of completing an audio/video connection panel under the portico to enable the use of direct hardwire connection to the microphones and WiFi system for the Sunday morning worship services in the parking lot. This will further improve the sound quality of the broadcast. We will be watching the parking lot carefully for damage from the winter. If major repairs are required in the spring, funds may need to be reallocated to the parking lot so any decision on what work is done next year will be done after we know the status and condition of the parking lot.

The usual monthly reminder: When the major repairs and replacement of parts of St. Paul was built into the budget 8 years ago, the congregation was advised that a 7% increase in giving would be able to support that plan. The congregation has been faithful to their unanimous approval and allowed St. Paul to make several improvements that have reduced the upkeep and operating expenses for the congregation. In the November congregation meeting, the financial report showed that the level of giving has decreased about 5% in the last year, making it difficult if not impossible to continue with the annual repairs in the future years. Please prayerfully consider what you may be able to do to help offset this decrease so that we can continue to make the necessary repairs and replacements before they become a more costly emergency situation.



The bags are designated for male or female based upon deodorant and sock type. On January 23rd a group led by Rev. Debbie Michaels put together close to 100 bags. Of those, over 25 were started and donated by Girl Scout Troop 50752 from Columbia Station. We have several of the bags in the office if you know of someone in need.

**1949** Pastor Vannorsdall ordained

**1952** – council approved \$400 to Board of Foreign Mission to assist with salary for Alta Madden in New Guinea

-relocation committee established to look for land for larger church building

1956 - Pastor Andersen installed

**1959** - On Feb 22, Redeemer Brook Park broke ground – St. Paul had done canvasing to establish a need for a church in Brook Park. Pastor Anderson attended as St Paul rep and as rep for District Mission Committee

**1967** - accepted bids for building of sanctuary

**1970** - Senior Center starts meeting at St Paul under leadership of Loni Flagner

Throughout the 1960s and 70s many members attended Have-a-Heart Dinners (begun in 1964) at Sheraton Cleveland, a fundraiser for Lutheran Children's Aid.

**1971** - On Feb 7, the Eagle Scout Award was presented to Keith Duncan, a member of St. Paul from the St. Paul Boy Scout Troop #421

1972 - on Feb 20, Pastor Bill Wilkins installed

1989 - Organ paid off

**1992** – began Mission Partnership with Living Word Lutheran Church, Medina. Pastor Begley there at the time.

- -Began fundraising for a Youth Mission Trip to Africa in June.
- -Began planning for "Good News" service to start in Sept during SS hour

1998 - Feb 8th Pastor Rauch's final service

2012 – Library moved from Parlor to area outside Fellowship Hall

# SHEEP AND GOATS FOCUS ST. PAUL EARLY EDUCATION CENTER



The scholarships have enabled us to defray tuition costs for eligible parents who could otherwise not send their children to preschool. However, this year due to the COVID-19 virus, we are asking anyone who is making a donation to consider making it to the preschool instead of the scholarship fund. We have some money in the scholarship fund but have a short fall in the preschool funds to cover expenses. This is due to the COVID-19 expenses and fewer children rerolled because of the virus. The scholarship funds may **only** be used for scholarships and **not used** for preschool expenses. They are always kept totally separate. Thank you for your ongoing support of the preschool.


