#### **Lent and Coronavirus**

Lent is a time when the Church reflects on the many sacrifices that Jesus made for his people, and we consider the sacrifices we are called by his example to make for each other. It isn't easy. Giving alms never is.

While there are exceedingly generous people out there, most of us tend to be a bit stingy. And when things get scarce, a lot of us turn into genuine hoarders. Doubt it? Have you gone out looking for toilet paper and hand sanitizer in your local stores? Perhaps you've noticed completely empty shelves. More people than we'd like to admit are responding to this Coronavirus outbreak with selfishness.

The ancient Lenten practices of prayer and fasting can help.

Whether you planned to fast or not, you're fasting now. Some people like to make fun of fasting, as if it were simply a silly relic of the past. Others mock fasting by asserting what they call their "Christian freedom." But none of that matters now. The universe has spoken. We're all fasting from something today.

Maybe we have enough food. More than enough, likely. But we're all being forced to fast. Some of us are fasting from going into our place of business. Some of us are fasting from going to shows, movies, or concerts. Most of us are fasting from seeing as many people as we'd like.

This time of forced fasting can be a time of deep spiritual reflection. When what we like is stripped away, that which is truly important comes into focus. Are you discovering what's truly important yet? Don't forget that lesson when things return to normal.


In the meantime, many of you will have some extra time on your hands (though, some of you will be working more than ever). Might I suggest that you use at least some of that time to pray. In your time of prayer, you might reflect again on those lessons that this forced fast is teaching you. As you pray for what you need, consider that your neighbor very likely needs those same things. Remember that when things return to normal.

If you remember the lessons that you're learning now, you may very well find giving alms to be easier on the other side of this Coronavirus outbreak. Having "gone hungry" yourself, you might be more sympathetic to those who "go hungry" every day in thousands of ways all around you.

We have not been able to gather together as a church this Lent. Maybe this will turn out to have been a good thing. Maybe we will learn more this Lent through this forced fast and isolation than we ever could have learned had we met as usual. If that's the outcome, then, one day, we will thank God even for this moment. Perhaps we do not even need to wait to offer our thanksgiving.

#### Income and Expenses Summary Notes:

#### Income

The YTD period ending February 29, 2020 has an operating surplus of \$4,620, a increase of \$9,790 from February 28, 2019, Congregational Contributions through February 2020 are \$2K more than contributions received through February 2019, but \$2,248 less than the surplus at the end of January. Building Use/Other Income is \$475 more than the amount at this time last year. Total Income at February 29, 2020, is \$2500K more than at February 28, 2019. Congregational Contributions are under budget by nearly \$11,600 and Total Income is under budget by nearly \$12,500 as of February 28, 2020.

Note: Other Income includes periodic gifts made by the Thrivent Choice Donation program, clothing recycling program, and other miscellaneous unrestricted income.

#### Expenses

Total expenses were under budget by nearly \$16K as of February 28, 2020. Total expenses YTD are \$5k less than total expenses as of February 2019.

Note: Benevolence payments are percentages of contributors. Therefore, when contributions are higher, benevolence payments are higher. In 2020, we budgeted 2% for the Synod only.

What will be your legacy to Saint Paul?

What will be your legacy to Saint Paul Lutheran Church? Do you wish to leave a healthy one? In order for you and me to leave any legacy, positive influences are needed.

For some time there has been some unhappiness by a few members. Everyone's feelings and opinions are important. Christian discussion of these was critical, especially at the beginning of the transition to our present pastor's ministry. Unfortunately, there has lately been an increase in negative talk. It appears that some of us insist on molding the details of sermons, ministry, and church administration into what they desire. We should ask ourselves "When did Saint Paul Lutheran Church become (put your name here) Lutheran Church?"

Even those with good intentions are being overshadowed by some spreading rumors with harmful intent to some of the staff. This has to stop.

We have always believed our Savior wants his church to be an inviting and attractive place for anyone and everyone. This means it is up to us to make it a house of worship for anyone and everyone. St Paul cannot be exactly what each of us desires it to be.

I can truly say in the thirty three years I have been a member of Saint Paul, I may never have been fully satisfied all of the time with every facet of our ministry. Be it the sermons, the music, outreach, money, liturgy, and more. But the overall benefit I receive from worshipping and serving Christ at Saint Paul overshadows any facet which may not fully appeal to me.

Your pastor and officers are listening to your concerns. Actions have been taken on issues which affect the congregation as a whole. We will continue in our efforts to grow our ministry. However, continuing to sow seeds of discontent in the hope that major changes will be made is counterproductive at best and more likely destructive to our church.

We know most members are positive about building our legacy for future generations and are happy with many of the changes that have been made. I am very excited about the approximately fifteen new worshippers I see on most Sundays which were not with us one year ago!

I can assure everyone that our staff, the Transition Call Team, your Church Council, members of both sexes, and those of all ages are behind our ministry. It is our hope that if you are not fully satisfied with certain aspects of our ministry that you make an effort to resolve or accept the differences and choose to move forward with us.

#### **DECISION TO CLOSE**

On Thursday March 12<sup>th</sup> Pastor Skillman and I spoke many times in regards to our responsibility to all members and to any visitors to St. Paul and what affect the Corona virus may have on anyone's health as well as the spread of the virus. Because we care about each of you we suspended all activities. Then the governor made it official.

At this time we do not know how long the restrictions will last. Our prayers are for anyone who may be ill from this or any other condition.

Due to rules imposed by our government visits to nursing homes, hospitals, those who are ill and at home, and those who meet the 'high risk' category are restricted. Thus, the pastor's ability to visit has been impacted.

Pastor Dan is making daily messages sent to your email. Be sure the office has your correct email address.

Due to restrictions some of you may be facing financial difficulties. Saint Paul has a Family Assistance Fund. It is not designed to supplement one's income but to help purchase critical items. This may be able to help.

The Sheep and Goats collection for April is The Family Assistance Fund, naturally.

Are you unable to leave your home? A group of members have graciously stepped up and offered to pick up your list of needed items for you. Please reimburse them. If you need this assistance please call the office.

The building is CLOSED to all but a critical few. We are serious about trying to help decrease the spread of the virus. Most codes and fobs have been shut down at this time. Your Council is abiding by the rules and is doing video conferences.

We should all pray as a family of believers for Jesus' healing and calming grace and have faith that this will soon pass.

#### PROPERTY COMMITTEE

At this time, our church is closed to all activities and visitors and the temperature in all rooms and the hallways, except for the church office, are at 55 degrees to conserve energy. The office staff continues to work so that emergency calls and needs can be forwarded as necessary, and to publish communications to the general membership. Eagle Cleaning has been busy disinfecting the interior of the entire building.

Once the virus emergency is over and we can again socialize and meet, things in our plans may be quite different. The plans that the public schools establish for re-opening may have a significant impact. Our plans to replace the Sanctuary roof were planned for after school is out so that there would be no danger to children who may get too close to the work zone. If the school year is not resumed immediately, having the roof replaced can be done earlier than expected, and hopefully the ancient office air conditioning system can also be replaced before the summer sun makes it difficult to work in the attic space over the office. A member has graciously donated funds to replace the office air conditioning system on our schedule instead of it being a panic when the 1974 system finally gives up and catches us by surprise.

Please continue to contribute to St. Paul's as you are able during this difficult time. Even conserving as best we can right now, it still requires some resources to keep the utilities on and our office operational.




#### ST. PAUL FAMILY ASSISTANCE
