(1 John 4:7-13)

There is no "why."
If we had an answer, that would be a condition.


As Lutherans, we find our life by being unconditionally loved, and we try to help others find life in the same by loving **them** unconditionally.

#### Income and Expenses Summary Notes:

#### Overall Comments and Income Review

The YTD period ending August 31, 2020, has an operating surplus of \$49,206, about \$50,700 more than at August 31, 2019, Congregational Contributions through August 2020 are a little more than \$3,200 less than contributions received through August 2019, a reduction of only 1.3%. The month of August saw a substantial increase in giving and reduced our giving deficit by nearly 4%. Total Income at August 31, 2020, is nearly \$10,000 less than at August 31, 2019. Congregational Contributions are under budget by nearly \$24,000 and Total Income is under budget by over \$29,000 as of August 31, 2020. Note that we are beginning to receive Building Use money again.

Note: Other Income includes periodic gifts made by the Thrivent Choice Donation program, clothing and paper recycling programs, and other miscellaneous unrestricted income. For the foreseeable future, we will not be receiving paper or clothing recycling income.

Total expenses are under budget by almost \$80,000 as of July 31, 2020. Total expenses YTD are almost \$60,000 less than total expenses as of August 2019. We remain more than 20% under budget. We will pay the roof repairs in September, which will increase YTD expenses by \$35,000.

Note: Benevolence payments are a percentage of contributions. Therefore, when contributions are higher, benevolence payments are higher. In 2020, we budgeted 2% for the Synod only.



#### PROPERTY COMMITTEE

As stated last month, the Property Committee, Worship Committee and Church Council continue to closely monitor the releases of information from the experts who are learning more about the Covid19 virus and evaluating what the new information tells us about how we can live in the safest possible way with it. Social distance, hand washing, and masks are still the major keys to protecting you and those you love from being infected. Hand washing is important because we are creatures of habit and will rub our eyes without thinking about the tiny virus that may be on our fingers. There are studies still being done regarding air movement by fans or air conditioning systems to determine the effective travel range of the tiny infected droplets. With our Sanctuary system, air discharge from floor vents will tend to push the droplets back into the air. For this reason we will continue to shut down the air conditioning or heating of the Sanctuary while it is in use.

Now that the Sanctuary roof is replaced, property emphasis will be shifting to replacing the office air conditioning system. The 46 year old system has served us well, but it is more than twice the age of most commercial systems when they fail. Hopefully the replacement will be a scheduled event and not an emergency issue.

The commercial refrigerator in the kitchen has a very small leak in the compressor which gradually reduces the unit's ability to cool. A charge of Freon will keep the unit functioning for 18 months or so, but eventually the temperature will not be sufficiently cold. Replacing the compressor on the 12 year old refrigerator will cost about half of the purchase price of a new commercial unit. Recharging the existing unit is a good economical band aid while we hold back on the purchase of a new refrigerator until our financial position has recovered a bit.

The usual monthly reminder: When the major repairs and replacement of parts of St. Paul was built into the budget 8 years ago, the congregation was advised that a 7% increase in giving would be able to support that plan. The congregation has been faithful to their unanimous approval and allowed St. Paul to make several improvements that have reduced the upkeep and operating expenses for the congregation. In the November congregation meeting, the financial report showed that the level of giving has decreased about 5% in the last year, making it difficult if not impossible to continue with the annual repairs in the future years. Please prayerfully consider what you may be able to do to help offset this decrease so that we can continue to make the necessary repairs and replacements before they become a more costly emergency situation.

#### Laura Barbins elected bishop of the ELCA Northeastern Ohio Synod

CHICAGO (Sept. 16, 2020) — The Rev. Dr. Laura Barbins, Mentor, Ohio, was elected Sept. 12 to serve a six-year term as the fifth bishop of the Northeastern Ohio Synod of the Evangelical Lutheran Church in America (ELCA). The election took place during an online synod assembly.

Barbins was elected on the fifth ballot, with 171 votes. The Rev. Angela Freeman-Riley, pastor of Bethesda on the Bay Lutheran Church in Bay Village, Ohio, received 148 votes.

The bishop-elect has served as pastor of Celebration Lutheran Church in Chardon since 2001 and adjunct faculty at Trinity Lutheran Seminary at Capital University in Columbus, Ohio, since 2018. Trinity is one of seven ELCA seminaries. Barbins served as interim pastor at Messiah Lutheran Church in Fairview Park, Ohio, from 1999 to 2000 and associate pastor for youth at Holy Trinity Lutheran in Nashville, Tenn., from 1995 to 1997.

The Rev. Dr. Barbins received a Bachelor of Business Administration degree from Roanoke College in Salem, Va., in 1990 and a Master of Divinity degree from the Lutheran Theological Seminary at Gettysburg (now United Lutheran Seminary) in Gettysburg, Pa., in 1994. United is one of seven ELCA seminaries. She received a Doctor of Philosophy degree from Vanderbilt University in Nashville, Tn., in 2004.

Bishop-Elect Barbins is married to the Rev. Dr. Paul Barbins, pastor of the Latvian Baptist Church of Cleveland and Program Coordinator of the Spiritual Program for Adults at St. Ignatius High School in Cleveland, Ohio. The Revs. Barbins have four daughters and live in Mentor, Ohio.

The Rev. Abraham D. Allende has served as bishop of the Northeastern Ohio Synod since 2014. Information about the Northeastern Ohio Synod is available at <a href="neos-elca.org/">neos-elca.org/</a>.



Trying to tell the difference between what expected behaviors are and what might be the signs of a mental health condition isn't always easy, but identifying a problem early can help lead to the best outcome.

# WARNING SIGNS of Mental Illness

Diagnosing mental illness isn't a straightforward science. We can't test for it the same way we can test blood sugar levels for diabetes. Each condition has its own set of unique symptoms, though symptoms often overlap. Common signs and/or symptoms can include:

- Feeling very sad or withdrawn for more than two weeks
- Trying to harm or end one's life or making plans to do so
- Severe, out-of-control, risk-taking behavior that causes harm to self or others
- Sudden overwhelming fear for no reason, sometimes with a racing heart, physical discomfort or difficulty breathing
- Significant weight loss or gain



- Excessive use of alcohol or drugs
- Drastic changes in mood, behavior, personality or sleeping habits
- **Extreme difficulty concentrating** or staying still
- Intense worries or fears that get in the way of daily activities

\*Various communities and backgrounds might view this sign differently based on their beliefs and experiences. Some people within these communities and cultures may not interpret hearing voices as unusual.

 ${\bf 2000}$  - Deb Michaels, daughter of our congregation, was installed at Holy Trinity Lutheran Church in Hickory NC


**2009** - Mary Turos resigned from youth director position
