Under Our Roof

One day, when Jesus entered Capernaum, the home of St. Peter, he was greeted by a Roman centurion. It seems unlikely that Rome would have had a garrison of soldiers stationed in this quiet fishing village in the territory of Herod Antipas.

Archeological evidence suggests that Rome didn't have any permanent troop outposts in Galilee until the second century. So, more likely than not, this Roman soldier traveled a long way to seek Jesus out.

A passing familiarity with the politics of Galilee in the 1st century renders the story that Matthew recounts in the 8th chapter of his Gospel (featured on the 3rd Sunday after the Epiphany) quite unexpected. Though Rome might not have often had a direct permanent military presence in the region, everyone knew that ultimately, they were in charge. And even though the people of Galilee were largely of mixed ethnicity and religion, their closest brothers and sisters were the Jewish people of Judea, and they shared many cultural and religious sensibilities in common with their "more pure" family from the south. Chief among those sensibilities was a desire for self-rule under God, and a throwing off of the Roman yoke.

The first things that are strange about Matthew's story are that a Roman centurion would seek out a Jewish/Galilean prophet with a request for help, and that Jesus, who would have been expected to share his culture's prejudices against Rome, would respond with anything other than a rebuke. But Matthew tells us that the Roman came, and that Jesus responded positively.

Roman: "Lord, my servant is paralyzed."

Jesus: "I will come and heal him."

Things get even more strange. The Roman refuses to let Jesus come to his home. He doesn't feel worthy. Ordinarily, the Roman would have looked at the Jew as an inferior. In this case, the Roman looks at Jesus as his lord.

Then comes the strangest part of the story. Jesus declares that no one in Israel has the faith of this Roman soldier, he welcomes him into the kingdom of God, and he heals his servant. It is a completely unexpected act of grace.

The historic liturgy of the church has at times included the centurion's words immediately prior to reception of the eucharist. "Lord, I am not worthy for you to enter under my roof, but say only the word and my soul shall be healed." Then the communicant receives the consecrated bread and wine through which Christ is said to come not only into one's house, but into one's very body.

Traditionally, the minister presiding over the eucharistic celebration has worn a poncho-like robe called a chasuble (which means something like, "little house") to remind the people that Jesus has indeed deemed to enter into our homes, and that at the moment of

reception, he comes closer than that. We become, in our bodies, little houses of the Lord, and he enters for our healing.

In our day, a suit and tie are perfectly acceptable dress at the altar for ministers of Christ's church. In some contexts, jeans and a T-shirt are even better. However, among those churches seeking to preserve ancient and venerable liturgical customs, one may find chasubles still in use.

The chasuble is the outermost liturgical vestment worn by clergy for the celebration of the Eucharist in Western-tradition Christian churches that use full vestments, primarily in Roman Catholic, Anglican, and Lutheran churches.

Income and Expenses Summary Notes:

Income

The YTD period ending November 30, 2018 has an operating deficit of almost \$31K, \$31K more than the deficit at December 31, 2018. Congregational Contributions through December 2018 are \$9K less than contributions received through November 2017. Note that December 2017 saw \$60k in contributions. Building Use/Other Income is \$5,500 less than the amount at this time last year. Total Income at December 31, 2018 is \$12K less than at December 31, 2017. Congregational Contributions are under budget by \$71K and Total Income is under budget by \$77K as of December 31, 2018.

Note: Other Income includes periodic gifts made by the St. Paul Preschool; the Thrivent Choice Donation program; paper recycling proceeds; and other miscellaneous unrestricted income. The MOW checking account was closed out with all proceeds to St. Paul in July 2018.

Expenses

Total expenses were under budget by \$46K as of December 31, 2018. Total expenses YTD are \$18K more than total expenses as of December 2017. Note: Benevolence payments are percentages of contributions. Therefore, when contributions are higher, benevolence payments are higher.







Their insights, dedication, and leadership have been invaluable, and we are blessed to have them remain on Council for 1 more year. Council held a mini "vision" retreat to discuss our mission as a church, our areas of emphasis when calling Pastor Dan, and ways to grow our ministry both inside and outside our walls. The results of this meeting will be forthcoming. I would be remiss if I did not mention our finances at the close of 2018. We ended the year with a deficit due to our obligations to staff and reduced congregational giving. This was not foreseen nor will it be recurring; however, we will be watching our expenses through the first Quarter.

February is surrounded by the season of Epiphany. One of the definitions of "epiphany" found in the Merriam-Webster dictionary is: "an appearance or manifestation especially of a divine being." Epiphanies are all around us if we only open our hearts and ears. This is a blessed congregation, and we your Council are honored to serve with you.

The Property Committee continues to concentrate on researching the details of proposed repairs and improvements, and then determining the scope, cost, and timing of the work required.

The Church Council has approved the proposed changes to the church office, so the work should begin very soon. There is a drawing of the coming changes and rearrangement in the hall window of the office.

The details of the project to re-roof the Sanctuary have also been reviewed. However, the Council has instructed Property not to award a contract until a clearer picture of this year income is evaluated. The financial shortfall for 2018 may force postponement of the work. The committee is also continuing to investigate the feasibility of adding a zone to the office air conditioning system to enable cooling of the youth room and possibly the nursery as well. The existing system is now over 40 years old so we are on borrowed time now. A special designated gift was received to cover the cost of replacing the office system, so the committee will develop specifications for two systems and see what additional cost might be involved to include the additional room(s) at this time.

In addition to the office air conditioning, Max Krug and E&L Heating and Cooling are evaluating a newly released web-based control system for the Sanctuary which utilizes much of the current pneumatic system components. This system would also be expandable to control most heating and cooling functions in the newer section of the building, allowing us really manage the energy used.

The committee is also investigating options on how to approach the repair of the rotted areas of wood framing around some of the stained glass windows. The goal is to find a band-aid to apply now to stop further damage, and then a longer term plan to repair the damaged wood in stages that we can financially support.

Thank to the Congregation for your continued faith in the Property Committee and the 15 Year Plan by approving of the 2019 Budget. Please prayerfully consider your giving status so that the Church Council and Property Committee can confidently proceed with the continued replacement of items before they fail and require emergency measures.


